


Under the rules of KRS 83A.130 I Mike Jones being the Mayor of the City of Drakesboro hereby veto ordinance 2022-07-01 for the following reasons:

- 1) This ordinance is not in the best interest for the tax payers of Drakesboro.
- 2) No lot and acreage ordinance is not in the best interest for the tax payers of Drakesboro.
- 3) Councilmen should have to maintain their lots and acreage in the City of Drakesboro.
- 4) It is not in the interests of the citizens of Drakesboro to live near, on, or in the vicinity of a property that is a health violation or a nuisance violation for weeds, debris, and garbage to accumulate.
- 5) It is not in the best interest for City Utilities to have to maintain service lines for water, sewer, or gas where weeds, debris, and garbage are allowed to accumulate.
- 6) It is not in the best interest for the City of Drakesboro's Fire Department to respond to a property that allows weeds, debris, and garbage to accumulate.
- 7) Citizens of Drakesboro who pay taxes should be assured by the City of which they live that their property values should not be affected by other properties which allow weeds, debris, and garbage to accumulate.
- 8) The citizens of Drakesboro should be protected by an ordinance that protects them from owners of properties that allow weeds, debris, and garbage to accumulate.
