AN ORDINANCE RELATING TO THE ESTABLISHMENT OF POLICY FOR PAST DUE GAS BILLS FOR THE CITY OF DRAKESBORO.

NOW. THEREFORE. BE IT ORDAINED BY THE CITY OF DRAKESBORG, KENTUCKY., AS FOLLOWS;

- 1. On the 15th day of each month any bill not paid will be past due.
- 2. After the 15th day of each month, a 10% late charge
- will be assessed to the customer.
 3. If bill has not been paid in full by the 20th day of month, weather permitting gas will be disconnected on the 21st day of menth.

4. The amount of the bill will be deducted from the deposit and a new deposit required.

5. There will be a \$15.00 charge to have gas turned back

6. All other ordinances and orders of the city in conflict herewith are hereby rescinded.

AN ORDINANCE RELATING TO THE ESTABLISHMENT OF POLICY FOR PAST DUE WATER BILLS FOR THE CITY OF DRAKESBORO.

NOW. THEREFORE. BE IT ORDAINED BY THE CITY OF DRAKESBORO, KENTUCKY., AS FOLLOWS.

- 1. On the 15th day of each month any bill not paid will be past due.
- 2. After the 15th of the month there will be a \$4.00 late charge, \$2.00 for water and \$2.00 for sewer will be assessed to the customer for any bill not paid in full.
- 3. On the 20th day of each month, if bill is not paid in full water will be turned off the 21st day of the month.
- 4. The amount of bill will be deducted from the deposit and a new deposit will be required.
- 5. After bill is paid there will be a \$15.00 charge to turn water back on.
- 6. All other ordinances and orders of the City in conflict herewith are hereby resainded.
